Certified employees will be paid on the BT-4 level until a valid clear renewable Georgia Professional Certificate is presented to the Personnel Department of Dooly County Schools. Certified employees who claim prior teaching experience will be paid on the E-entry level salary step until the experience has been officially verified in accordance with Georgia Department of Education standards. Employees who work less than the full 190 day school year will be paid at the daily rate of pay multiplied by the total number of days worked for the remainder of the school year. It is the employee's complete and total responsibility to obtain verification of prior teaching experience and certification in the State of Georgia.
