Q. How often may I receive eye care services?

Because there are no frequency limitations with this Vision Perfect eye care plan, you may use your set annual eye care dollar amount for covered eye care procedures such as comprehensive eye exams, frames, prescription lenses and contacts.

Q. Do I need to complete a claim form?

Yes. You will pay the provider for services, then file a claim to Ameritas for reimbursement. Ask your provider to complete Ameritas Eye Care Claim Form GC314 available from ameritasgroup.com, so you can send it in for reimbursement.

Q. May I take advantage of coupons/special offers from retail locations?

Yes. With Vision Perfect, you may take advantage of special offers, promotions or coupons. Ameritas will reimburse you for all covered eye care expenses up to your set annual eye care dollar amount — even if you take advantage of “buy one get one free” offers.

Q. What are some of the cosmetic options I may expect to pay extra for?

Lens options such as ultra-violet coating, scratch-resistant coating and tinting are not currently reimbursable under this Vision Perfect plan.

Q. Why is the contact lens exam not covered as part of my comprehensive eye exam? why is it considered to be different?

While the comprehensive eye exam is designed to catch eye problems or other medical issues, the contact lens exam is a separate exam specifically for contact lens wearers. It ensures the proper fit of your contacts, evaluates your vision with the contacts for potential risk, and often includes training for care and use. The comprehensive exam and the contact lens fit and follow-up exam are reimbursable up to your set annual eye care dollar amount.

Q. What type of contact lenses may I purchase through Vision Perfect?

All contact lenses containing a prescription, including disposables, are reimbursable up to your set annual eye care dollar amount.
